

# **Product Change Notification**

#### To: Our Valued Distribution Customer

The purpose of this notification is to communicate a product change of select Renesas Electronics America, Inc. (REA) devices.

This notification announces a change to the embossed tape (tape & reel) width of select RX100/200/600 devices in the 14x14mm LQFP package manufactured at Renesas Semiconductor (Beijing) Co., Ltd. (RSB). The tape width will change from 32mm to 24mm.

The pocket width, pocket depth, feed hole, dimension between feed hole and pocket center, reel width, and cover tape width change due to the change in tape width. See the appendix for details.

There is no impact to the part number, fit, form, specifications, characteristics, quality & reliability of the products.

#### **Affected Products:**

A review of our records indicates the list of products in the appendix may affect your company.

Part numbers given in this list are for active part numbers in REA database at the time of this notification.

#### **Key Dates:**

Shipments from REA of devices in the new tape width begins. Cross shipments of product in the old and new tape width may occur for a period of time.

If the customer does not make any objections to this notification within 90 days of the receipt of the notification, then Renesas will consider the notification as approved. If customer cannot accept the notification, then the customer must provide Renesas with a last time buy demand and purchase order.


